Introduction:

The Undergraduate Certificate in Post Compulsory Education course has been developed and approved to meet the national Education and Training Foundation Standards (ETF) for teachers working in the Life Long Learning Sector. The course has been devised by the University of Wolverhampton and its partner colleges, with a view to providing a coherent course of study, which enables teachers to be able to reflect upon and develop within their teaching role. The Lifelong Learning Sector includes teaching professional and vocational qualifications in colleges, sixth form colleges, adult education centres, offender education, private training providers and work-based learning.

Benefits:

This course provides the theoretical knowledge and practical support needed to gain the accreditation of a highly regarded initial teacher training qualification.

Course Length:

The course will be offered on a part-time day basis over two years.

Assessment:

Continuous assessment – through assignments, research projects, teaching practice and presentations.

4. Employed as an in-service teacher within the Lifelong Learning Sector and able to provide evidence of at least 60 hours of teaching practice experience per year whilst studying the Undergraduate Certificate course.

Alternatively applicants can arrange their own voluntary placement for teaching but this must be approved and negotiated with the course tutors prior to course commencement. This must be within the Lifelong Learning Sector and able to provide evidence of at least 60 hours of teaching practice experience per year whilst studying the Undergraduate Certificate course.

Please find attached the reference forms which must be completed by the supervising person offering the teaching hours. They will sign and confirm the teaching hours provided. Please note that BMet staff need only provide one reference form. Students based at other organisations MUST provide two reference forms.

5. A satisfactory Disclosure and Barring Service Check (DBS).

Please note: Any of the above evidence not presented at interview will result in only a conditional offer being made.

Progression:

The University of Wolverhampton has devised a range of qualifications which allow progression from the Undergraduate Certificate in Post Compulsory Education course to degrees and post-graduate awards.

Tuition fee: The tuition fee for the academic year 2019/2020 is £2,975 per year and is subject to change for the academic year 2020/2021. Please note these fees apply to students from the UK or EU.
