TUITION FEE POLICIES

BMet

When you enrol at BMet on a course where the College has responsibility for collecting the tuition fee you will be required to provide one of the following methods of payment:

- Tuition Fee Loan from Student Finance England – support notification letter (please note if your loan isn't approved when you enrol for your course you will be required to show that you have submitted your application for financial support to Student Finance England)
- one-off payment - by bank transfer, credit card or debit card
- instalments – initial payment by bank transfer, credit card or debit card followed by four monthly instalments by direct debit
- employer – a purchase order, on company headed paper, agreeing to pay the fees

Following enrolment, if you decide to withdraw from your course of study the tuition fee liability due will be:

Day 1 to Day 14	0%
Day 14 to end of Term 1	25% of the total tuition fee
Day 14 to end of Term 2	50% of the total tuition fee
Day 14 to end of Term 3	100% of the total tuition fee

FINANCIAL SUPPORT AVAILABLE FOR UNIVERSITY LEVEL COURSES

Student Finance England

The Government offers a wide range of student financial support in the form of grants, loans and university/higher education institution bursaries. If you're studying a BA (Hons) Degree, BSc (Hons) Degree, Foundation Degree, Higher National Certificate, Higher National Diploma or Post Compulsory Education course you can apply for financial support from the government through Student Finance England. The main sources of help available are grants which you don't pay back and loans which you do.

If you are eligible you can apply for:

- Tuition Fee Loan – to help with the cost of tuition fees
- Maintenance Loan – to help with accommodation and other living costs
- Childcare Grant – to help with childcare costs for children under 15, or under 17 if they have special educational needs (full-time students only)
- Parents' Learning Allowance – to help students with children pay for learning costs (full-time students only)
- Adult Dependents' Grant – to help students with an adult who depends on them financially (full-time students only)
- Disabled Students' Allowance – to help students with a disability
- NHS Bursary – to help students who are studying certain medical, dentistry or healthcare courses (applies to BSc (Hons) Degree Podiatry students)

Please note that the College is sadly unable to grant a tuition fee waiver of any sort, regardless of personal circumstances.

Eligibility Criteria

If you qualify for financial support from Student Finance England depends on:

- your course
 - all courses listed above are eligible for financial support
- if you have studied a higher education course before
 - you will normally only get financial support if you are doing your first higher education qualification
- your age
 - there is no upper age limit for tuition fee loans although if you are 60 or over you may get limited funding for Maintenance Loans if you meet specified criteria
- your nationality or residency status
 - you can submit an application for financial support if all the following apply:
 - you are a UK national or have 'settled status'
 - you normally live in England
 - you have been living in the UK, Channel Islands or the Isle of Man for 3 years before starting your course

- if your residency status is one of the following you may be eligible for financial support:
 - refugee
 - granted leave to remain or a child of someone granted leave to remain
 - granted 'Calais leave' to remain or a child of someone granted 'Calais leave' to remain (your course must have started on or after 1 August 2020 and you have lived in the UK for at least 3 years before the first day of the first academic year of your course)
 - humanitarian protection
 - EEA migrant worker
 - child of a Swiss national
 - child of a Turkish worker
 - a stateless person (including eligible family members) and you are a new student starting on or after 1 August 2018
- if you are not a UK national and you are one of the following you may be eligible for financial support:
 - from an EU country which includes students from the European Economic Area (EEA)
 - under 18 and have lived in the UK for at least 7 years
 - 18 or over and have lived in the UK for at least 20 years (or at least half of your life)

Loan Repayments

The earliest you will start repaying any loans

- if you are studying full-time – the April after you leave the course
- if you are studying part-time – the April 4 years after the course started

and only when your annual income is over £26,568 (before tax and other deductions). You will stop paying if your income drops below this amount. You pay back 9% of your income over the minimum amount of £25,568.
